Sales Policy

The CVW Long Lake Public Library allows musicians, writers, and other performers who are contracted to perform at the Long Lake Public Library or at event sponsored by the Long Lake Public Library to sell recordings, books, or decorative items produced by the performer on the day of the program. Sales will be allowed at performances including, but not limited to, concerts, workshops, readings, and book signings. Performers must comply with all federal, state, and county regulations regarding sales and are responsible for obtaining all required federal, state, and county permits, certificates, or licenses. Performers must provide the CVW Long Lake Public Library with proof of valid New York State tax certificate. Library staff cannot provide information or guidance on federal, state, or country regulations, permits, certificates, or licenses. Library staff and volunteers will have no responsibility for selling items for performers. Sale items may not be left at the library.

Performer Sales Information

The Cornelius Vanderbilt Whitney Long Lake Public Library requires all performers selling recordings, books, and other items related to performance to meet Federal, State and Local Laws and Regulations pertaining to their business operations. The following general information is provided to assist you in obtaining necessary permits, licenses, and certifications. It is the responsibility of the performer to investigate and comply. Copies of permits, licenses, and certificates must be submitted to the Library.

4. Tax Rates

Tax of 8% must be charged on recording, books, crafts, decorative items (including gourds and decorative corn), candy, baked goods, etc.

The following items are tax exempt in Hamilton County: food (dairy, edible produce, meat), clothing, etc.

Tax rates and regulation may change and it is the responsibility of performer to ensure that they are charging and reporting correct taxes.
