Approved: On Motion by Rick, seconded by Bob, with all in favor of approving the **Election Resolution** showing the annual levy of \$163,708, and one trustee vacancy and appoints

Micaela Hall and Maxine Rider as Election Inspectors with a compensation rate of \$75 each for those serving

Richard Winn said that if more money was placed in CDs, the wage increases would be covered.
